


## Landscape level habitat restoration



Highlights of 2 current major projects

### Reotahi - Second Full Sweep Complete

- Reotahi Reserve 65ha
- 39ha controlled for over 30 species of invasive weeds
- 720 WANHRT and Aki Tai Here contractor hours between July and October 2024
- Track logs maintained coverage and informed planning
- Signs of greatly reduced weed burden reported by kaimahi
- Thanks to this second round of funding from Lotteries Envrionment, native regeneration is flourishing



Track logs map of Manaia courtesy of Aki Tai Here


## DoC Threatened Species

- Over 20ha controlled by WANHRT and Aki Tai Here contractors/kaimahi on lower Manaia slopes for 15 high impact ecological weeds in order to protect the upper Manaia threatened species habitats
- Upskilled alongside DoC and NRC experts., Increased native ID skills
- New finds of threatened plant species as a result
